

- Moving from pilot projects (AEMET seed money) to Operational Services / Activities Extension (time or geographical areas) is possible (additional funds)






Lessons learned

- MARINEMET Project Pilot (1.672.130,34 €, 4 countries) is over 60% of the total cost incurred so far.
 - It is necessary extend the benefits to the rest of coastal countries
 - It is necessary to consolidate a partnership with other donors

Hence, mobilisation resources activities and manpower (expertise) of countries and AEMET to consolidate a proposal are need for MARINEMET OPS Service Project, but also for "Others"
